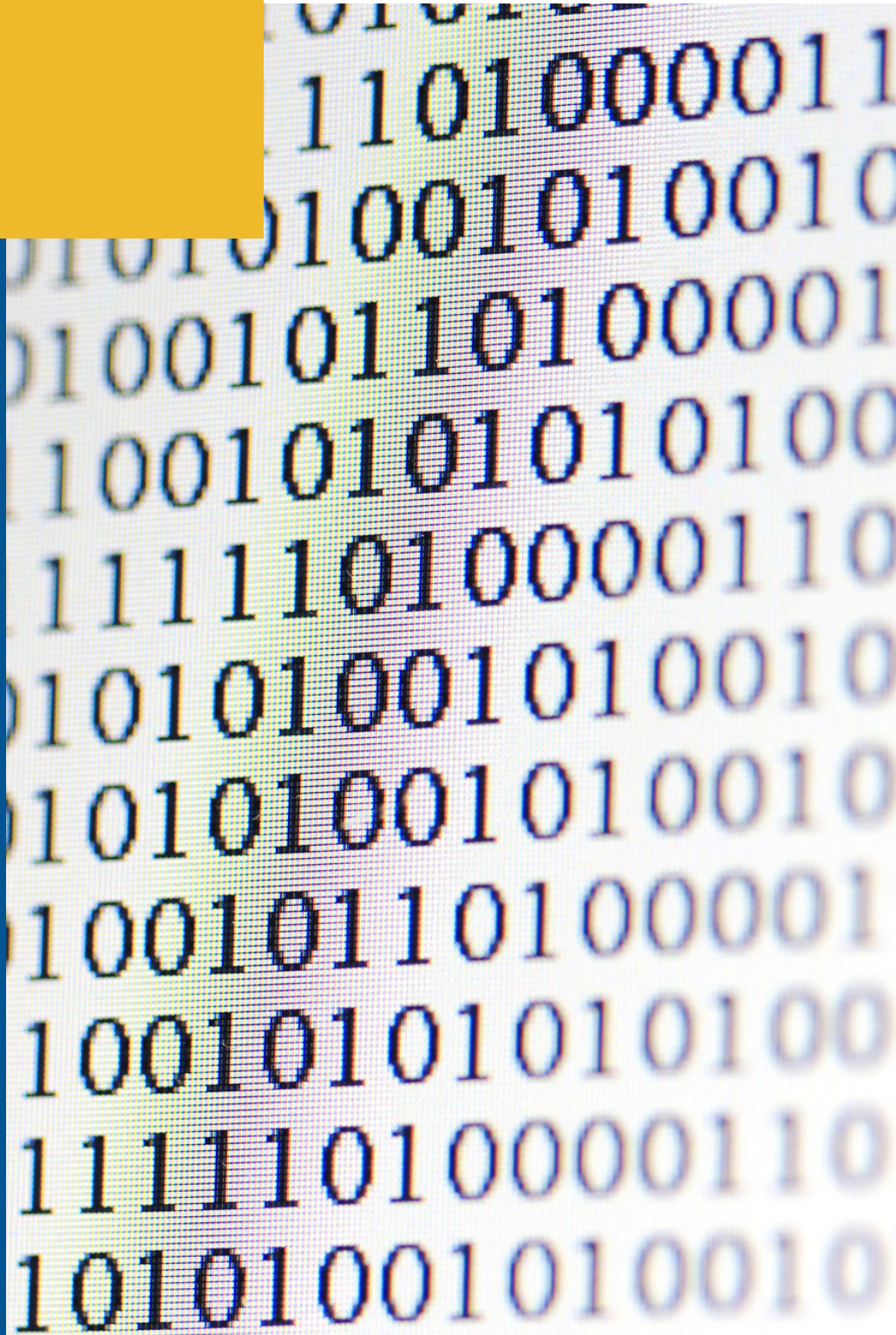

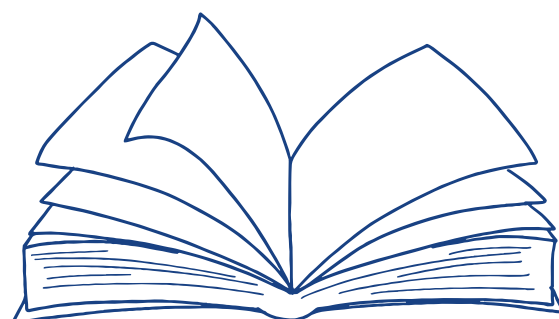
THE THB HANDBOOK FOR ONLINE INVESTIGATORS AND ANALYSTS

The Trafficking in Human-Beings (THB) Handbook for Online Investigators and Analysts has been finalized!

The handbook aims to assist the end-user (LEA) partners, prosecutors, intelligence analysts and other public and private experts in their work towards combatting THB! The handbook encompasses the following topics:

1. Different types of THB;
2. Indicators for THB: Digital Society, New Technologies and Human Trafficking;
3. Conducting investigations using OSINT: SOCMINT and HUMINT;
4. CIT Management: Technically integrating OSINT Data
5. DeepWeb and Crypto Wallet Analysis: Cyber laundering;
6. Cross-border and public-private cooperation with a focus on intelligence exchange
7. Judicial Cooperation;
8. Victims- centered Approach

The first training held in Trento, Italy was delivered to 50 participants, who joined us from the State and Finance Police, The Labor Inspectorate and The Carabinieri!

The training was conducted in a blended modality, where a general theoretical outlook was given to the participants, followed by a hands-on approach where all the technologies actively used in the project were tested out! The VR training was specifically tailored to encompass the key points for trafficking in human-beings, which created an interactive and fruitful learning environment for the participants!

The second day concerned a theoretical training on operational approach to document verification, followed by a practical document analysis workshop!

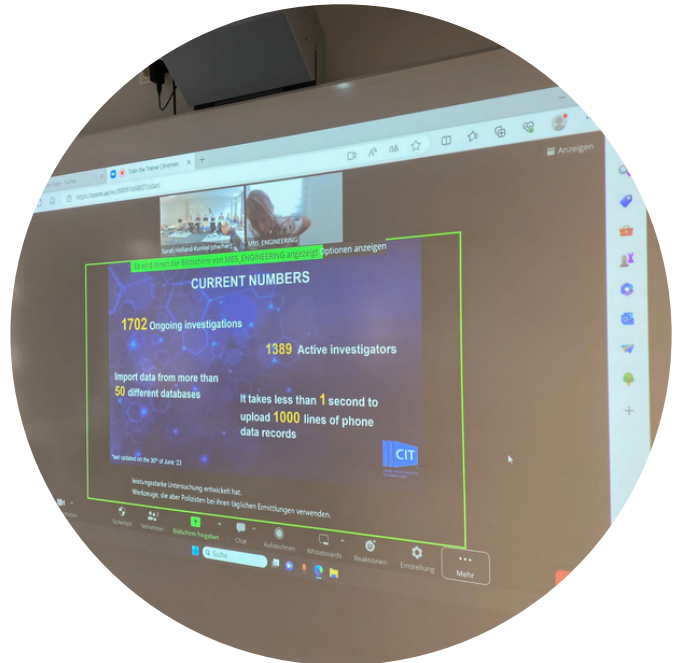
